## Sachverhalt

- Proof of payment of the minimum capital; in the case of cash formation: Proof by submitting a bank confirmation or bank statement,
- if an existing company is recognised as an auditing company: interim financial statements not older than three months,
- Declaration by each shareholder that they do not hold the shares in the auditing company for the account of a third party. This may be waived if the articles of association contain a corresponding prohibition,
- Employment contracts of the partners working in the company who are not auditors (sworn auditors, tax consultants, lawyers, tax agents, etc.) and who are not legal representatives, and
- Certificates from foreign professional organisations regarding the approval or recognition of EU/EEA auditors and EU/EEA audit firms

## Verfahrensablauf

It is advisable to submit the draft articles of association to the Chamber of Public Accountants for review before submitting the application. Any necessary notarisation can then take place.

- Submit the application for recognition to the Chamber of Public Accountants and enclose the necessary evidence. You can submit the application on the homepage [www.wpk.de](https://www.wpk.de/) in the "My WPK" area, for which you log in with your registration number and password. There you will also receive the information sheet for recognition as an auditing company.
- After entry in the commercial or partnership register, the Chamber of Public Accountants recognises the company as an auditing company by issuing a certificate of recognition.
