To do so, you must provide evidence of the required knowledge and skills. 	<p>documents and evidence.</p> <ul style="list-style-type: none"> <li>• After the Chamber of Crafts has reviewed your application, you will receive written notification as to whether and to what extent the authorisation to practise will be granted.</li> <li>• An entry will be made in the Register of Qualified Craftsmen.</li> </ul> <p>The Chamber of Crafts can also grant the authorisation to practise subject to conditions, requirements or for a limited period of time or restrict it to a significant part of the activities that belong to a skilled trade listed in Appendix A.</p>

weiterführende Informationen	<p>"Old journeyman regulation"</p> <p>Without a master craftsman's examination, you can also obtain a licence to practise some trades in accordance with Section 7b of the German Crafts Code (HwO) if you have completed relevant training as a journeyman or skilled worker and have worked in the trade for at least six years - at least four of which must have been in a managerial position.</p>
