Please note: Even if you are authorised to work on Sundays and public holidays, you must observe special features and restrictions, such as collective agreements, regulations on breaks and rest periods or provisions on maternity protection. A substitute rest day must be granted for work on Sundays and public holidays.

Voraussetzungen	Applications for the suspension of Sunday and public holiday rest can be authorised by the Landesdirektion Sachsen • in the commercial sector on up to ten Sundays and public holidays per year on which special circumstances make extended business operations necessary (Section 13 (3) No. 2a ArbZG), • on up to five Sundays and public holidays per year if special circumstances make this necessary to prevent disproportionate damage (Section 13 (3) No. 2b ArbZG), and • on one Sunday per year to carry out a statutory inventory (Section 13 (3) No. 2c ArbZG).
