Volltext	The Federal Office of Economics and Export Control (BAFA) supports the installation of combined heat and power (CHP) plants up to 20 kW upon application with a one-time investment grant (mini CHP grant). The central aim of this subsidy is to significantly increase the use of highly efficient CHP plants in this output range and thus contribute to achieving the national climate protection targets. Tip: Grid operators pay an electricity tariff for state-approved CHP plants, regardless of their output. For plants up to 50 kW, the Federal Office of Economics and Export Control introduced a simplified approval procedure.
