Voraussetzungen	<p>Eligible applicants</p> <ul style="list-style-type: none"> • small and medium-sized enterprises in trade and industry and other service industries • Members of the liberal professions <p>The registered office and business operations must be in Germany.</p> <p>In particular, companies that are granted relief within the framework of the Spitzenausgleich (Section 10 Electricity Tax Act and Section 55 Energy Tax Act (Energiesteuerergesetz)) are not eligible to apply, nor are companies that have submitted an application in the current or previous calendar year pursuant to Sections 63 et seq. EEG (special equalisation scheme).</p>

Bearbeitungsdauer	
Frist	<p>Submit your application before you make use of the counselling service. The start of the measure is considered to be the conclusion of the performance contract. You can take advantage of the implementation support (to be applied for individually) at your own risk as soon as your application has been received by the Federal Office.</p>
