The Federal Commissioner for Data Protection and Freedom of Information is the point of contact for complaints about • all public bodies of the federal government , • Telecommunications and postal service companies • Federal courts, insofar as they are involved in administrative matters.
Erforderliche Unterlagen	Documents that facilitate the BfDI's review or prove the alleged data protection violation (recommended)
Voraussetzungen	You feel that your fundamental right to informational self-determination has been violated.

Verfahrensablauf	• Submit your complaint in writing, verbally, by telephone or electronically (see -> Online application) to the Federal Commissioner for Data Protection and Freedom of Information (BfDI). • Describe the facts of the case in your complaint. • Name the allegedly responsible body. • The BfDI will investigate your complaint, clarify the facts and, if necessary, remedy any breaches of data protection law. • You will be informed of the result of the investigation. **Note:** Violations of data protection regulations can lead to the initiation of criminal or fine proceedings.
