Voraussetzungen	• The day-care centre provider decides on admission • the child should be at least six months old (exceptions see below) • physical and mental health
Kosten	Parental contribution in Saxony: maximum 23 per cent of staff and material costs. The exact amount is determined by the municipal or city council.

Verfahrensablauf	Enquire about the registration formalities directly with the independent provider or the crèche operator. Note: Organise a place in the crèche in good time!

Frist	• Registration: no later than six months before the desired start of childcare (applies to all providers). • Registration at short notice is possible if a childcare place is available. Enrolment before the birth is not possible. • Exception: Daycare centres with permission to accept children after the end of the maternity protection period (children aged eight weeks)
