Verfahrensablauf	The most important instrument for LEADER areas to implement their strategy is thematic calls. Citizens, companies, associations and municipalities can apply for funding for their projects. The LEADER areas select the projects for funding that best serve the regional objectives. The selection of a project by the LAG does not constitute a funding commitment. The decision on eligibility for funding is made by the responsible approval authority.
