recognition of the training occupation.

The reference occupations in the forestry sector include the recognized training occupations in accordance with Section 4 of the Vocational Training Act (-> see "Requirements").

Single Point of Contact (Einheitlicher Ansprechpartner)

For this procedure, you can use the service of the Single Point of Contact. They will guide you through the administrative procedure, take care of correspondence with all the offices responsible for your request and will be available to you as a competent advisor.

Erforderliche Unterlagen

Please complete the application in full and enclose all documents required under Section 5 (1) BQFG:

1. a tabular list in German of the training courses you have completed and the gainful employment you have held,
2. proof of identity (passport or ID card),
3. proof of education acquired abroad,
4. proof of relevant professional experience or other proof of qualifications, if these are required to establish equivalence, and
5. a declaration that no application for a determination of equivalence has been submitted to date.

The documents numbered 2 to 4 must be submitted to the competent body in the form of originals or certified copies. Translations in German of the documents number 3 and 4 are to be submitted. The translations must be prepared by a publicly appointed or sworn interpreter or translator.

Voraussetzungen

You must have the intention to pursue gainful employment in Germany.

Furthermore, you need a foreign professional qualification for one of the following professions:

- forester
- forestry machine operator
- forestry manager
