The nature conservation authority grants the permit upon application for certain facilities and certain operators and sets a maximum number of animals of each species.</p> <p>According to the Federal Nature Conservation Act (BNatSchG), zoos are permanent facilities where animals of wild species are kept for at least seven days a year in order to display them.</p>

Kosten	Fees: depending on the procedure according to the administrative cost law
Verfahrensablauf	Apply for the Zoo permit in writing and informally to the responsible office. The responsible office will inform you about the further steps of the procedure.
