In order to be eligible for this funding, proof of an appropriate pre-qualification must first be provided by the department responsible for the examination.</p>
Volltext	<p>Confirmation of pre-qualification to apply for Aufstiegs-BAföG according to §9 of the Upgrading Training Assistance Act - AFBG</p> <p>Further education qualifications such as master, business administrator, master-professional can be financially supported by Aufstiegs-BAföG. In order to be eligible for this funding, proof of an appropriate pre-qualification must first be provided by the department responsible for the examination.</p> <p>One document that serves as proof is the "Form Z". On this form, you must have the competent department confirm that you meet the professional admission requirements for the examination or can meet them by the time of the examination.</p> <ul style="list-style-type: none"> • The competent department for IHK occupations is the Chamber of Industry and Commerce (Industrie- und Handelskammer/IHK) • You usually qualify either by having completed your first professional training and/or through initial work experience. • Even if you have dropped out of university, have professional experience or have a Bachelor's degree, you can prove that you have the required prior qualification. The exact requirements are set out in the examination regulations for the respective continuing education qualification.
