Voraussetzungen	• Management of the facility by a veterinarian or performance of veterinary and technical tasks by a contractually bound veterinarian • the necessary personnel and all facilities required for the collection, treatment, storage and delivery of semen or ova and embryos • Compliance with animal health requirements for maintaining the health of livestock and carrying out animal health examinations of male breeding animals at an insemination centre

Verfahrensablauf	• For authorisation as an insemination centre or embryo transfer facility, you must submit an (informal) written application to the responsible department. • In addition to checking the documents submitted, an on-site inspection will also take place. • If all requirements are met, the responsible department will send you the licence and invoice. • You can also apply for changes and extensions in writing to the responsible department.

Hinweise	• Anyone operating a semen collection centre must immediately keep records of the collection, treatment, storage and release of semen in accordance with a statutory order pursuant to Section 18 paragraph 1 no. 4 • Operators of an embryo collection team or other semen collection centre, a semen storage centre or other embryo collection team must immediately keep records of the delivery of the respective products
