Verfahrensablauf	Make an appointment with the counselling centre. If available for your location, use the online registration via Amt24 (see -> Online application and forms). After the individual health counselling by the health office, you will receive a certificate with which you can register with the public order office. This certificate

	contains: • the first and last name of the person being counselled • the date of birth of the person being counseled • the issuing office • the date of the health counselling Note: The initial certificate is valid for three months. Within this period, registration with the public order office must take place.
