Have electronic copies of the required documents ready. • Follow the link to the online application and fill in the data fields according to the instructions. You can save the information at any time and complete it later. • Once all data fields have been filled in and the listed documents have been compiled, complete the application and the data will be sent to the competent office. • You will find the application confirmation in the inbox of your service account. For incoming messages, you will receive a notification to your personal e-mail address. If you cannot use the online services, submit a written application with the required documents. If necessary, use the available forms of the insolvency court. The information will be provided immediately depending on the workload.
