Volltext	 #### Application for recognition of a foreign professional qualification as a career qualification in accordance with § 20 of the Saxon Civil Service Act (SächsBG) in conjunction with §§ 12 ff. Saxon Career Ordinance (SächsLVO) Professional qualifications are qualifications evidenced by training certificates or relevant professional experience. If you have acquired your qualification in a legal profession in another EU member state, EEA contracting state or a state equated by agreement, it can be recognised as equivalent to a career qualification upon application. The prerequisite for recognition is that the qualification required for a career in the Free State of Saxony. You can compensate for substantial differences up to a certain extent by taking an adaptation course or an aptitude test. You are entitled to an examination to determine whether your professional qualification can be recognised for one of the following specialisations and focuses in the Free State of Saxony:





- * Judicial clerk
- * Bailiff
- * Public prosecutor
- * Graduate in public administration (in the prison service)
- * Civil servant in the general prison service
