Volltext	<ul> <li>#### Application for recognition of a foreign professional qualification as a career qualification in accordance with § 20 of the Saxon Civil Service Act (SächsBG) in conjunction with §§ 12 ff. Saxon Career Ordinance (SächsLVO)</li> <li>Professional qualifications are qualifications evidenced by training certificates or relevant professional experience. If you have acquired your qualification in a legal profession in another EU member state, EEA contracting state or a state equated by agreement, it can be recognised as equivalent to a career qualification upon application.</li> <li>The prerequisite for recognition is that the qualification required for a career in the Free State of Saxony. You can compensate for substantial differences up to a certain extent by taking an adaptation course or an aptitude test.</li> <li>You are entitled to an examination to determine whether your professional qualification can be recognised for one of the following specialisations and focuses in the Free State of Saxony:</li> </ul>





- \* Judicial clerk
- \* Bailiff
- \* Public prosecutor
- \* Graduate in public administration (in the prison service)
- \* Civil servant in the general prison service
