In this case, your degree will be recognised. • If there are differences, you will have to take an aptitude test. <p>#### Aptitude test</p> <p>The aptitude test consists of a written and an oral part. The written part of the examination consists of two written examinations. The oral examination consists of a short lecture and a discussion.</p>
