	by the Chamber of Industry and Commerce (IHK) must prove that the applicant has been instructed in the knowledge required to practice the trade).
	• Social concept (Pursuant to Section 33c (2) of the Trade, Commerce and Industry Regulation Act (GewO), a social concept must be submitted in order to obtain a permit to install gaming machines with the possibility of winning. The social concept describes the measures to be taken to prevent the socially harmful effects of gambling).
	• Excerpt from the Commercial Register (Handelsregisterauszug) or, in the case of legal entities still in the process of being established, the certificate of incorporation and shareholders' agreement.
Voraussetzungen	• A permit according to § 33c Gewerbeordnung requires your reliability under trade law. The reliability is checked by the authority during the application process.

Verfahrensablauf	<ul> <li>First, you must obtain all the necessary documents and submit them to the authority with the written application.</li> <li>The authority checks your reliability under trade law.</li> <li>If all requirements are met, you will receive the permit with a fee notice.</li> </ul>
