Volltext	According to the Tierschutzgesetz, animals must be fed, cared for and housed in a manner appropriate to their species. Animals must not be restricted in their ability to exercise in a way that causes them pain, avoidable suffering or harm. Anyone who kills a vertebrate animal without reasonable cause will be penalised. Anyone who tortures an animal by inflicting considerable pain or suffering on it out of cruelty or by inflicting pain and suffering that lasts for a long time or is repeated is also liable to a custodial sentence or a fine. If you observe such offences, you should report them. You should also report the offence if you have reasonable grounds for suspicion.
