Volltext	Apply for a certificate for the tax office for VAT exemption according to § 4 number 20a sentences 2 and 3 of the Value Added Tax Act (UStG) According to the VAT Act, the following organisations of legal entities under public law, among others, are exempt from VAT: • Theatres, orchestras, chamber music ensembles, choirs • Museums, botanical gardens, zoological gardens, animal parks • Archives, libraries The same applies to the turnover of similar institutions of other companies if the competent state authority certifies that they fulfil the same cultural tasks as the state institutions. Note on competence In the Free State of Saxony, certificates of VAT exemption for cultural institutions are issued by State Directorate of Saxony: • Theatres, orchestras, chamber music ensembles and choirs

Verfahrensablauf	You can submit your application for a VAT certificate for cultural organisations in an informal letter, in writing or electronically to the responsible office. The responsible tax office will decide on the VAT exemption. Online service Set up a service account in Amt24 and use it to log in to the service portal. Have electronic copies of the required documents ready. • Follow the link to the online service(see -> Online application) and complete the data fields according to the instructions. You can save the information at any time and complete it at a later date. • Upload the required documents(see -> Required documents). • Once all data fields have been completed, finalise the application and the data will be sent to the responsible office. • You will find the application confirmation in the inbox

of your service account. You will receive a notification of incoming messages to your personal e-mail address.

If you do not wish to use the online service, a PDF form is available as an alternative.

The responsible office will check the application received and, if necessary, make additional requests for missing or inadequate documents.

If all requirements are met, you will receive a written notification of the VAT certificate for submission to the tax office.
