These are</p> <ul style="list-style-type: none"> • Healthcare, nursing and geriatric care facilities • Obstetrics facilities • Physiotherapy facilities <p>To extend the SMC-B, you must first reapply for the right to use the card from the electronic healthcare professional register (eGBR). You then apply for the SMC-B from a trust service provider (VDA). VDAs charge an annual fee, which varies from provider to provider.</p>

Verfahrensablauf	<p>You can renew the SMC-B online as a nursing, obstetrics or physiotherapy facility:</p> <ul style="list-style-type: none"> • Go to the specialised portal of the electronic healthcare professions register (eGBR) and complete the online application • Once your application has been received, it will be checked. • The review costs an administrative fee. • Once the check has been completed, you will receive an email with the result of the check and your process number. • You can use the transaction number to order an SMCB from a trust service provider (VDA) of your choice for a fee.
