Teaser	If you are transporting more than 60 liters of a non-bottled wine product, you need a wine accompanying document for each transport.
Volltext	You require a wine accompanying document for the transportation of wine products that have not been bottled.

	Wine products are • Grapes, • grape must, • mash, • wine, • sparkling wine, • sparkling wine, • liqueur wine and • fortified wine. The accompanying document entitles you to transport the wine products from the producer to the further processing or recovery point, for example to a winery. You are obliged to use an accompanying document.
