Teaser	If you as a citizen transfer weapons and/or ammunition that require a permit, you must notify the competent authority within two weeks.
Volltext	If you transfer your licensed weapon and/or ammunition to another person, you must report this to the relevant weapons authority within two weeks. The competent weapons authority will then delete the entry for the weapon and/or ammunition from your weapon possession card (WBK) and, if applicable, from your European firearms pass. You do not have to report if you • you transfer essential parts of the weapon in order to have embellishment work or similar work carried out and then receive them back after the work has been completed,
