Teaser	Have you successfully passed the master craftsman's examination and would like to work independently in a trade requiring a license? If so, you must first register your business in the Register of Craftsmen.
Volltext	<ul> <li>natural persons</li> <li>partnerships and</li> <li>legal entities</li> <li>who operate a craft requiring a license as a standing trade. Itinerant trades and market trades are not classified as permanent trades.</li> <li>You can find a complete list of trades requiring a license in Appendix A of the Crafts Code (HwO). The trade does not have to be exercised as a whole, as the exercise of essential (partial) activities is also possible. Conversely, it is conceivable that several trades or essential activities of several trades are to be practiced.</li> <li>Furthermore, the business manager who is responsible for the professional and technical management of the craft business and who has the necessary professional qualification to practice the craft requiring a license is</li> </ul>

entered in the Register of Craftsmen. Both the owners of craft businesses and employed persons are eligible as managers. Proof of qualification is provided by submitting the master craftsman's certificate for the craft or related craft to be practiced.

# Erforderliche Unterlagen

For sole proprietorships:

- Identity card or comparable identification document (copy)
- Master craftsman's certificate (copy)
- Business registration (copy): Can be submitted after entry in the trade register

For civil law partnerships (GbR):

- Identity card or comparable identification document of the partners (copy)
- Partnership agreement, if not concluded informally (copy)
- Master craftsman's certificate of the personally liable partner responsible for the technical management of the business or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the trade register

For commercial partnerships entered in the commercial register:

- This refers to
- General partnership (OHG)
- Limited partnership (KG)
- corresponding foreign company forms

 Identity card or comparable identification document of the shareholders or authorized representatives (copy)

For companies domiciled in Germany:

- for companies entered in the commercial register: extract from the register, articles of association (copy)
- if not entered in the register: articles of association (copy)
- Master craftsman's certificate of the personally liable partner or shareholder responsible for the technical management of the company or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For foreign legal forms:

- Extract from the register, if already entered in the foreign register, otherwise articles of association (copy)
- Master craftsman's certificate of the personally liable partner responsible for the technical management of the business or the partner or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For legal entities:

- This refers to
- Limited liability company (GmbH)
- Entrepreneurial company (haftungsbeschränkt)
- public limited company (AG)
- registered cooperative (eG)

- Identity card or comparable identification document of the authorized representatives (copy)
- for companies based in Germany: extract from the register, articles of association (copy)
- for foreign legal forms: Register excerpt from the relevant foreign register, articles of association (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen
- Details of the company management
- Master craftsman's certificate of the employed management

If you employ a manager, you must also submit the following information

- Declaration of plant manager
- Employment contract (copy)
- Proof of social insurance of the plant manager (copy)
- Master craftsman's certificate (copy)

If you employ a second person as a manager, you must also submit the manager's declaration with the other documents mentioned for this person. This may be the case, for example, if you wish to exercise several trades requiring a license as a standing trade.

You, the personally liable partner responsible for the technical management of the company or your company management require a master craftsman's certificate

Kosten	The amount of the fees can be found in the fee schedule of the responsible Chamber of Crafts.
Verfahrensablauf	You can apply for entry in the Register of Craftsmen in writing or, in some cases, online at your local Chamber of Crafts. Please obtain information about the procedure from the relevant Chamber of Skilled Crafts. You can also have the necessary documents sent to you.
	<ul> <li>Submit your application documents to your local Chamber of Skilled Crafts</li> </ul>
	• The Chamber of Skilled Crafts will check your application for completeness
	<ul> <li>Once you have been registered, you will receive a written certificate from your local Chamber of Skilled Crafts. Your company will receive the so-called craftsman's card</li> </ul>
	<ul> <li>If the registration is rejected, you will receive a notification from the local Chamber of Skilled Crafts</li> </ul>
Bearbeitungsdauer	If all documents are complete and no further procedure is necessary, the Chamber of Skilled Crafts must make the entry in the Register of Skilled Crafts within 3 months, otherwise the entry is deemed to have been made after this period has expired. Processing time: 3 months
Frist	You must be entered in the Register of Craftsmen before starting work.
