Teaser	<p>If you have successfully completed an engineering degree or obtained a technician's qualification, you can become self-employed in the craft requiring a license that corresponds to the main focus of your studies or school examination.</p>
Volltext	<p>The Register of Craftsmen is a register in which all</p> <ul style="list-style-type: none"> <li>• natural persons</li> <li>• partnerships and</li> <li>• legal entities</li> </ul> <p>who operate a craft requiring a license as a standing trade. Itinerant trades and market trades are not classified as permanent trades.</p> <p>You can find a complete list of trades requiring a license in Appendix A of the Crafts Code (HwO). The trade does not have to be exercised as a whole, as the exercise of essential (partial) activities is also possible. Conversely, it is conceivable that several trades or essential activities of several trades are to be practiced.</p> <p>Furthermore, the business manager who is responsible</p>

for the professional and technical management of the craft business and who has the necessary professional qualification to practice the craft requiring a license is entered in the Register of Craftsmen. Both the owners of craft businesses and employed persons are eligible as managers. Proof of qualification can be provided by submitting a university degree certificate or the certificate of a passed technician examination. The focus of study or schooling must correspond to the craft that is to be practiced.

The relevant chambers of skilled crafts provide further information on this service. Please contact the relevant Chamber of Crafts for more information.

## Erforderliche Unterlagen

For sole proprietorships:

- Identity card or comparable identification document (copy)
- University degree certificate or certificate of passed technician examination (copy)
- Business registration (copy): Can be submitted after entry in the trade register

For companies under civil law (GbR):

- Identity card or comparable identification document of the partners (copy)
- Partnership agreement, if not concluded informally (copy)
- University degree certificate or certificate of having passed a technician examination (copy) of the personally liable partner responsible for the technical management of the business or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the trade register

For commercial partnerships entered in the commercial register:

For companies based in Germany:

- for companies entered in the commercial register: extract from the register, articles of association (copy)
- if not entered in the register: articles of association (copy)
- University degree certificate or certificate of having passed a technical examination (copy) of the personally liable partner responsible for the technical management of the company or of the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For foreign legal forms:

- Extract from the register, if already entered in the foreign register, otherwise
- Articles of association (copy)
- University degree certificate or certificate of having passed a technician examination (copy) of the personally liable partner or shareholder responsible for the technical management of the business or the employed management (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For legal entities:

- Limited liability company (GmbH)
- Entrepreneurial company (haftungsbeschränkt)
- public limited company (AG)
- registered cooperative (eG)
- Identity card or comparable identification document of the authorized representatives (copy)
- for companies based in Germany: extract from the register, articles of association (copy)
- for foreign legal forms: Extract from the register of the competent foreign register, articles of association (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen
- Details of the company management
- University degree certificate or certificate of successful completion of a technician examination (copy) of the employed company management

If you employ a manager, you must also submit the following information

- Plant manager's declaration
- Employment contract (copy)
- Proof of social insurance of the plant manager (copy)
- University degree certificate or certificate of having passed a technician examination (copy)

If you employ a second person as manager, you must

	also submit the manager's declaration with the other documents mentioned for this person. This may be the case, for example, if you wish to exercise several trades requiring a license as a standing trade.
Voraussetzungen	<p>You, the personally liable partner responsible for the technical management of the company or your company management must have successfully completed a university degree or training as a state-certified technician.</p> <p>The focus of their studies or training must correspond to the craft requiring a license that is to be practiced.</p>
Kosten	The amount of the fees can be found in the fee schedule of the responsible Chamber of Crafts.
Verfahrensablauf	<p>You can apply for entry in the Register of Craftsmen in writing or, in some cases, online at your local Chamber of Crafts. Please obtain information about the procedure from the relevant Chamber of Skilled Crafts. You can also have the necessary documents sent to you.</p> <ul style="list-style-type: none"> <li>• Submit your application documents to your local Chamber of Skilled Crafts</li> <li>• The Chamber of Skilled Crafts will check your application for completeness</li> <li>• Once you have been registered, you will receive a written certificate from your local Chamber of Skilled Crafts. Your company will receive the so-called craftsman's card</li> <li>• If the registration is rejected, you will receive a notification from the local Chamber of Skilled Crafts</li> </ul>
Bearbeitungsdauer	<p>If all documents are complete and no further procedure is necessary, the Chamber of Skilled Crafts must make the entry in the Register of Skilled Crafts within 3 months, otherwise the entry is deemed to have been made after this period has expired.</p> <p>Processing time: 3 months</p>

- Craft requiring a license in the standing trade
- Name and qualifications of the company management
- Company owners or managers must provide proof of a technical university degree or a technician's degree in the specialization corresponding to the craft to be practiced
- Proof of qualification: university degree certificate, technical certificate
- Application can be submitted in writing or partially online to the local Chamber of Skilled Crafts
- Deadline: before taking up the craft activity
- Fees: Amount depends on the fee schedule of the relevant Chamber of Skilled Crafts
- Responsible: Chamber of Skilled Crafts in whose district the commercial establishment is intended
