Teaser	<p>If you wish to work independently in a craft requiring a license with a professional qualification acquired abroad and the equivalence to a domestic master craftsman's examination has been established, you must first have this entered in the Register of Craftsmen.</p>
Volltext	<p>The Register of Craftsmen is a register in which all</p> <ul style="list-style-type: none"> <li>• natural persons</li> <li>• partnerships and</li> <li>• legal entities</li> </ul> <p>who operate a craft requiring a license as a standing trade. Itinerant trades and market trades are not classified as permanent trades.</p> <p>You can find a complete list of trades requiring a license in Appendix A of the Crafts Code (HwO). The</p>

trade does not have to be exercised as a whole, as the exercise of essential (partial) activities is also possible. Conversely, it is conceivable that several trades or essential activities of several trades are to be practiced.

Furthermore, the business manager who is responsible for the professional and technical management of the craft business and who has the necessary professional qualification to practice the craft requiring a license is entered in the Register of Craftsmen. Both the owners of craft businesses and employed persons are eligible as managers. Proof of qualification is provided by submitting the certificate of equivalence of the professional qualification with the domestic master craftsman's examination of the respective craft or related craft to be practiced.

## Erforderliche Unterlagen

For sole proprietorships:

- Identity card or comparable identification document (copy)
- Notification of the equivalence of the professional qualification with the domestic master craftsman's examination (copy)
- Business registration (copy): Can be submitted after entry in the register of craftsmen

For companies under civil law (GbR):

- Identity card or comparable identification document of the partners (copy)
- Articles of association, if not concluded informally (copy)
- Notification of the equivalence of the professional qualification with the domestic master craftsman's examination of the personally liable partner responsible for the technical management of the

business or the employed management (copy)

- Business registration (copy): Can be submitted after entry in the Register of Craftsmen

For commercial partnerships entered in the commercial register:

- This refers to
- General partnership (OHG)
- Limited partnership (KG)
- corresponding foreign company forms
- Identity card or comparable identification document of the shareholders or authorized representatives (copy)

For companies domiciled in Germany:

- for companies entered in the commercial register: extract from the register, articles of association (copy)
- if not entered in the register: articles of association (copy)
- Notification of the equivalence of the professional qualification with the domestic master craftsman's examination (copy) of the personally liable partner responsible for the technical management of the company or the partner or the employed management (copy)

- Business registration (copy): Can be submitted after entry in the register of craftsmen

For foreign legal forms:

- Extract from the register, if already entered in the foreign register, otherwise articles of association (copy)
- Notification of the equivalence of the professional qualification with the domestic master craftsman's

examination of the personally liable partner responsible for the technical management of the business or the employed management (copy)

- Business registration (copy): Can be submitted after entry in the register of craftsmen

For legal entities:

- This refers to
  - Limited liability company (GmbH)
  - Entrepreneurial company (haftungsbeschränkt)
  - public limited company (AG)
  - registered cooperative (eG)
  - Identity card or comparable identification document of the authorized representatives (copy)
  - for companies based in Germany: extract from the register, articles of association (copy)
  - for foreign legal forms: Extract from the register of the competent foreign register, articles of association (copy)
  - Business registration (copy): Can be submitted after entry in the register of craftsmen
  - Details of the company management
  - Notification of the equivalence of the professional qualification with the domestic master craftsman's examination of the employed management (copy)
- If you employ a manager, you must also submit the following information
- Declaration of plant manager
  - Employment contract (copy)

- Proof of social insurance of the plant manager (copy)
- Notification of the equivalence of the professional qualification with the domestic master craftsman examination (copy)

If you employ a second person to manage the business, you must also submit the business manager's declaration and the other documents mentioned for this person. This may be the case, for example, if you wish to exercise several trades requiring a license as a standing trade.

## Voraussetzungen

You, the personally liable partner or partner responsible for the technical management of the company or your company management require recognition of the equivalence of the professional qualification with the domestic master craftsman's examination (copy)

- in the craft requiring a license or
- in a craft related to this

with which you wish to become self-employed in a standing trade.

## Kosten

The amount of the fees can be found in the fee schedule of the responsible Chamber of Crafts.

## Verfahrensablauf

You can apply for entry in the Register of Craftsmen in writing or, in some cases, online at your local Chamber of Crafts. Please obtain information about the procedure from the relevant Chamber of Skilled Crafts. You can also have the necessary documents sent to you.

- Submit your application documents to your local Chamber of Skilled Crafts
- The Chamber of Skilled Crafts will check your application for completeness
- Once you have been registered, you will receive a written certificate from your local Chamber of Skilled

Bearbeitungsdauer	<p>If all documents are complete and no further procedure is necessary, the Chamber of Skilled Crafts must make the entry in the Register of Skilled Crafts within 3 months, otherwise the entry is deemed to have been made after this period has expired. Processing time: 3 months</p>
Frist	<p>You must be entered in the Register of Craftsmen before starting work.</p>

- partnerships and
- legal entities
- Legal obligation to register:
  - all business owners with a craft requiring a license in a standing trade must be registered in the craft register
  - does not apply to itinerant trades or market trading
- Register contents include
  - Craft requiring a license in the standing trade
  - Name and qualification of the company management
  - Possibility of registering the established equivalence of a professional qualification acquired abroad with a domestic master craftsman qualification in a craft requiring a license
  - Proof of qualification: notification of the equivalence of the professional qualification with the domestic master craftsman examination
  - Application can be submitted in writing or partially online to the local Chamber of Skilled Crafts
  - Deadline: before taking up the craft activity
  - Fees: Amount depends on the fee schedule of the responsible Chamber of Crafts
  - Responsible: Chamber of Skilled Crafts in whose district the commercial establishment is intended
