Volltext	You must be entered in the Register of Craftsmen if you wish to work independently in a craft requiring a license in Germany. This also applies if you only want to carry out a significant part of a craft requiring a license on a self-employed basis. Registration in the Register of Craftsmen is possible for • natural persons and partnerships and • legal entities. The Chamber of Skilled Crafts issues a certificate of registration in the form of a skilled crafts card. The following is noted on the craftsman's card • Name and address of the owner, • place of business,

- the craft requiring a license to be operated or the crafts requiring a license to be operated,

- Date of registration,

- name of the company management.

You do not have to renew the craft card annually, as it remains valid until the data provided changes or is deleted.

You must be entered in the register of craftsmen.

The specific fee can be found in the Chamber of Crafts' schedule of fees, which is available on the Chamber's website.

You apply for entry in the Register of Craftsmen and receive the Craftsman's Card as proof of your successful registration.

(craftsman's card) - issue

- Registration in the Register of Craftsmen is required if a craft requiring a license is to be operated independently. The Chamber of Crafts issues a craftsman's card as proof of entry in the register of craftsmen

- Craftsman's card:

- is issued automatically after entry in the Register of Craftsmen

- does not have to be renewed annually

- contains:

- Name and address of the owner,

- place of business,

- the craft requiring authorization to be operated or the crafts requiring authorization to be operated,

- Date of registration,
