Arbitration is an institution for the pre-court and out-of-court settlement of certain legal disputes.

**Volltext**

Legal disputes do not always have to be settled immediately in court. Arbitration proceedings often suffice as a more time-saving and cost-effective alternative. Arbitration is an institution for the pre- and out-of-court settlement of certain legal disputes. This applies to both civil and criminal matters. In every municipality, there are honorary arbitrators who are elected for a period of five years. Their task is to mediate between disputing parties and find solutions to legal disputes. They are bound to absolute confidentiality, even after their term of office, and are authorized to reach legally binding agreements.
