| Teaser                           | If you have a temporary residence permit for mobile<br>researchers and would like to continue your work at<br>the research institution in Germany after the expiry of<br>the time limit, you can extend your residence permit<br>under certain conditions   |
| Volltext                         | The residence permit for the purpose of research for<br>mobile researchers is a temporary residence title. You<br>can apply for an extension of the residence permit if<br>you want to continue your work at a research<br>institution beyond the period of validity of your<br>residence permit. |
|                                  | Apply for the extension of your residence permit at the<br>foreigners authority responsible for your place of<br>residence no later than eight weeks before the expiry<br>of the time limit.  |
|                                  | The same requirements apply to the extension of the residence permit for the purpose of research as to its issue. In particular, you should be able to present a hosting agreement or a corresponding contract with a research institution.   |
|                                  | In the case of an extension, your residence permit will be limited again. The residence permit for the purpose  |

Your fingerprints will be taken for the issuing of the electronic residence permit (eAT).</li> <li>In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment for an interview at the Aliens' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the issuing of the eAT card.</li> <li>If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced.</li> <li>After about six to eight weeks, you can collect your eAT card from the Aliens' Registration Office.</li> </ul> |

| Kurztext          | <ul> <li>Residence permit for the purpose of employment<br/>Extension for mobile researchers</li> <li>Residence permits for the purpose of research for<br/>mobile researchers can be extended if their period of<br/>validity is due to expire in the near future and the<br/>activity at the research institution is to be continued.</li> <li>The extension must be applied for at least eight<br/>weeks before the expiry of the time limit.</li> <li>An extension of the residence permit for the purpose<br/>of research for mobile researchers is only possible if<br/>the prerequisites that existed when it was first issued<br/>continue to be met.</li> <li>In the course of the extension, the residence permit<br/>will again be limited in time.</li> <li>An extension is excluded if this was already ruled out<br/>by the Foreigners' Registration Office when the permit<br/>was first issued or when it was last extended.</li> <li>Depending on the Foreigners' Registration Office and<br/>the issue, the application can be made via the Internet<br/>or only in person.</li> <li>There are fees for the extension. The time and the<br/>form of payment vary depending on the authority.</li> <li>Responsible: Foreigners authority responsible for the<br/>applicant's place of residence.</li> </ul> |
