Volltext	<p>Working as a mine surveyor is subject to legal regulations in Schleswig-Holstein. Only persons who have been recognized as such by a senior mining authority or by the Clausthal-Zellerfeld senior mining authority (now the State Office for Mining, Energy and Geology) may work as mine surveyors. Only these are authorized to use the professional title "mine surveyor" to use.</p> <p>Recognition is only granted to persons who have passed the mine surveyor examination and have proven their reliability with regard to the operation of the mine surveyor trade.</p> <p>Recognition can be withdrawn by the State Office for Mining, Energy and Geology.</p>

In the case of an application from another country, the office checks whether the foreign qualification is equivalent to the German qualification. 4. The competent body will inform you of the result in writing or electronically by means of a decision (direct recognition, requirement of a compensation measure or rejection). 5. If necessary, the examination office will ask you to complete an adaptation period or an aptitude test for recognition if direct recognition is not possible. 6. If you have completed the
