Teaser	If you are unable to take a fishing license test due to a disability, you can apply for a special permit.
Volltext	You can apply to the higher fishing authority for an exemption from the fishing license requirement if you are unable to take a fishing license test due to a disability. The permit allows you to fish with a hand-held fishing rod accompanied by an adult holder of a valid fishing license. The exemption can be granted for an indefinite period of time. Exemptions from the fishing licence requirement issued under comparable conditions in another federal state are recognized in Schleswig-Holstein.
Erforderliche Unterlagen	• Severely disabled person's pass (copy front and back) • If applicable, a medical certificate stating that the fishing license test cannot be taken due to the severe disability
Voraussetzungen	• Minimum age: from the age of 12 • Authorization from the applicant, if applicable • The requirement as to whether the respective severe disability prevents the applicant from taking a fishing license test must be checked.
Kosten	Abgabe: Es fallen keine Kosten an The exemption permit itself is free of charge, but is sent together with the fishing tax stamp. The fishing tax of 10 euros must also be paid before fishing

Verfahrensablauf	• You submit the application in writing to the higher fisheries authority • You receive an exemption permit by post • You pay the fees for the fishing tax
Bearbeitungsdauer	2 - 4 Woche(n)
Frist	The validity of the exemption is andependent on the time limit on the disabled person's ID card.

Hinweise	• An identity card must also be carried when fishing • An accompanying adult in possession of a valid fishing license must be present when fishing. The accompanying person must supervise the fishing and ensure compliance with the applicable laws and fishing regulations. • Only valid for fishing with a hand-held fishing rod
