| Volltext                      | If you intend to operate X-ray equipment or handle radioactive materials, a certificate of competence from the competent authority is required. To do this, you must first successfully complete a recognized course to acquire specialist knowledge. You then apply to the competent authority for a certificate of professional competence. The authority will then examine your documents and the requirements and, if the examination is positive, will certify your specialist knowledge. It should also be noted that you must update your specialist knowledge after five years at the latest. |
