Teaser	If you want to produce a digital game, you can receive funding for the creation of the game under certain conditions.
Volltext	Small and medium-sized enterprises based or operating in Schleswig-Holstein are eligible for funding. The funding of games is subject to cultural criteria (cultural test). A significant proportion of the creative work within the framework of the planned funding project (e.g. concept development, programming, music recordings, design) must take place in Schleswig-Holstein. The planned game must meet the requirements for the protection of minors and receive or have received an age rating from a recognized institution of voluntary self-regulation (USK).
Erforderliche Unterlagen	• Extract from the commercial register • Alternatively: Business registration in connection with a copy of the identity card of the person authorized to represent the company • Culture test • Annex to the cross-sectional objectives (scoring sheet) • Project description • Concept/prototype of the game • Proof that project staff are employed by the company (e.g. employment contracts) • Proof of qualifications of all project staff

Voraussetzungen	• The project must not have been started yet. • The company must be based/operate in Schleswig-Holstein. • The applicant company must be a small or medium-sized enterprise. • No other federal funding programs (in particular computer game funding) or the European Union (EU) may be used for the project applied for. • The planned project must meet the requirements for the protection of minors. • The cultural test must be met. • The project must contribute to the cross-cutting objectives (equality, non-discrimination and sustainable development). • Module 2 of the funding program must already have been completed or an existing concept or prototype must be submitted.

Verfahrensablauf	• Registration with the company account of the country • Preparation and submission of the application • If an application for an early start has been submitted, a written approval for the early start will be issued. The project can then begin. • Final review of the application by the granting authority • Issue of a grant notification (in the event of a positive review) • Receipts and supporting documents must be submitted for reimbursement of eligible expenditure. • Payment of the funding (in installments) • Submission of the proof of use (factual report; proof of project expenditure) • Final notification
