Volltext	<p>The funding measure is aimed at cross-sector investments by companies to strengthen the adaptability and competitiveness of the regional economy and to compensate for locational disadvantages in the sense of a balanced and equivalent spatial development in Schleswig-Holstein. Funding is provided in the GRW funding area.</p> <p>A special section is dedicated to the accommodation industry. The market- and target group-oriented development of accommodation establishments is a key component of the "Schleswig-Holstein 2030 Tourism Strategy".</p> <p>Operational investments in conjunction with a well-developed tourism infrastructure will increase demand outside the peak season. The funding is intended to help strengthen tourism as an economic factor and improve the competitive position of the</p>

It is recommended that you seek advice from Investitionsbank Schleswig-Holstein beforehand. • Investitionsbank Schleswig-Holstein will check the application and request any missing documents or information. • Once a complete application has been submitted, Investitionsbank Schleswig-Holstein will decide whether to approve the funding. • There is no legal entitlement to funding. • A project can only be started before the funding is approved if you apply for an early start of the measure and this is approved by Investitionsbank Schleswig-Holstein.
Bearbeitungsdauer	Processing regularly takes several months.
Frist	We recommend seeking advice from Investitionsbank Schleswig-Holstein before submitting an application. The application must be submitted before the start of the project. The project may not be started without approval.
