	On the one hand, the Digital Learning Campus (DLC) consists of a digital learning and collaboration platform on which you can set up your own access profile at the latest when the DLC learning locations are launched and which will later also cater to individual learning preferences. On the other hand, the DLC consists of a series of physical learning and collaboration locations networked via the platform.
	This is expected to be offered at the university locations in Flensburg, Kiel, Heide and Lübeck, where learning and collaboration will be accompanied by tutors and trainers.

	 advice from Investitionsbank Schleswig-Holstein beforehand. • Investitionsbank Schleswig-Holstein will check the application and request any missing documents or information. • Once a complete application has been submitted, Investitionsbank Schleswig-Holstein will decide whether to approve the funding. There is no legal entitlement to funding. • A project can only be started before the funding is approved if you apply for an early start of the measure and this is approved by Investitionsbank Schleswig-Holstein.
Bearbeitungsdauer	Processing takes at least 1-2 months, but can regularly take several months.
Frist	The deadline for submitting an expression of interest to Investitionsbank Schleswig-Holstein expired on 03.05.2023. After receiving the invitation to apply and before submitting the application, we recommend that you seek advice from Investitionsbank Schleswig-Holstein. The application must be submitted before the start of the project. The project may not be started without approval.
