Verfahrensablauf

You can submit an application online or in writing.
If you would like to submit your application online:

- You submit your application on the service portal of the state of Schleswig-Holstein.
- Your organization will need a service account on the Schleswig-Holstein service portal and an ELSTER organization certificate. The latter is used to authenticate your organization's service account.
- The submitted project applications are evaluated by an expert jury consisting of representatives of the ministry responsible for the funding call and Investitionsbank Schleswig-Holstein as the approval authority on the basis of a scoring model and confirmed by the ministry.
- Investitionsbank Schleswig-Holstein approves your application or initially grants an early start of the measure due to the short-term start of the project. Granting an early start does not result in a legal entitlement to funding. The project may not be started without a grant notification or the granting of an early start, otherwise funding is excluded.

If you would like to submit the application in writing:

- You fill in the application form provided on the website of Investitionsbank Schleswig-Holstein and send it to Investitionsbank Schleswig-Holstein with the original signature.
