Volltext	If you would like to carry out a project to secure skilled workers in Schleswig-Holstein, you can receive funding with the help of a non-repayable grant for project financing as part of the Schleswig-Holstein Skilled Workers Initiative (FI.SH).
	Funding is available for projects to develop and test measures to secure skilled workers, particularly in the following areas
	<ul> <li>Improving the matching of job supply and demand</li> <li>Recruitment of skilled workers in so-called shortage occupations</li> <li>Attracting skilled workers and employees from abroad</li> </ul>
	<ul> <li>Strengthening the development of skilled workers for a climate-neutral economy</li> <li>Regional skilled labor projects</li> <li>Skilled worker networks for industries</li> </ul>
	The funding is granted as pro rata financing with a maximum amount and does not have to be repaid.
	The maximum amount of funding is 70 percent of expenditure.

	Personnel expenses are granted according to the actual expenditure principle and a lump sum of 40 percent.

Bearbeitungsdauer	An application can be submitted at any time. Note for further information on the processing time: Once the application has been received, the team will contact you after an initial review of the application regarding further processing. The processing time depends on the individual effort required to process the application.
Frist	1 - 3 Jahr(e) Approval for a project is granted for a minimum of one year and a maximum of three years. It must be completed by the time the guideline expires.

Hinweise	Projects from which only a single company benefits are excluded from funding.  The documents to be submitted in the application and in the other documents are relevant to the subsidy. A declaration to this effect must be submitted as part of the application. The granting authority must be informed immediately of any changes to facts relevant to the subsidy.
