- You call up the online service.
- Select the district or independent city in which you draw water.
- If you withdraw water in different districts, you must submit one notification per district.
- You enter the quantities of water withdrawn and their use (withdrawal purposes) as well as the withdrawal locations.
- If any information is missing, you will be asked to provide further information.

If you wish to submit the notification in writing:

- Complete the appropriate form, if offered by your competent authority.
