| Teaser                           | Does your child have problems in everyday life or in<br>their development? As a parent, do you need support<br>in raising your child? Then raising your child in a day<br>group may be a possible solution.  |
| Volltext                         | Education in a day group is particularly suitable for<br>children from school age who show behavioral<br>problems or developmental delays. This is a type of<br>educational support service. It may also be suitable for<br>young adults in accordance with §41 SGB VIII.<br>A day group is what is known as partial inpatient help.<br>Your child will be looked after in a day group during<br>the week after school. Afterwards, however, they can<br>stay with their family and thus in their familiar<br>surroundings.<br>Education in a day group means<br>• Your child receives therapeutic and educational care<br>• It receives support with integration into school and<br>the social environment<br>• It learns how to deal with other children and<br>conflicts in a group<br>• It learns to organize its everyday life and receives<br>suggestions for meaningful leisure activities.<br>• Parents are intensively involved, for example<br>through counseling sessions, parents' evenings or<br>parent-child meetings. |

| Voraussetzungen                 | <ul> <li>You are the person with custody of a child (parent or guardian)</li> <li>You feel overwhelmed with the upbringing of the child</li> <li>Help with raising your child in a day group is suitable and necessary.</li> </ul>  |
| Kosten                          | The costs for education in a day group are largely<br>borne by the youth welfare office. However, you must<br>contribute to the costs to a reasonable extent. Please<br>ask the responsible youth welfare office about this.  |
| Verfahrensablauf                | <ul> <li>Contact the responsible youth welfare office.</li> <li>All parties involved (you, your child, the caregivers from the day group and the youth welfare office) will meet to discuss a help plan. The help plan sets out how the help is to be organized and what goals are to be achieved.</li> <li>If education in a day group seems appropriate, you can submit an application for educational assistance.</li> <li>The youth welfare office will look for a suitable day group. You can express your wishes. If there are several options, you can choose the day group.</li> <li>Regular checks are carried out to determine whether the help is still suitable.</li> </ul> |
