The permit in accordance with § 3 of the Gaming Halls Act expires if the owner has not commenced operation within one year of its issue or has not operated the establishment for a period of one year. The deadlines can be extended for good cause.

Hinweise

Anyone wishing to operate an amusement arcade as a "traveling trade" requires a permit from the competent authority for the respective place of business in accordance with Section 60a GewO. Please note that different fees may be associated with this than with the granting of a permit in the "standing trade".

For the installation of gaming machines, an additional permit pursuant to Section 33c (1) GewO is required. Furthermore, a certificate regarding the suitability of the installation site is required for each installation site in accordance with § 33c Para. 3 GewO.

All information is provided subject to any necessary examination under building law. Further details can be found in the service descriptions for building law(building application).
