Teaser

Temporary structures require a building permit before they are erected and put into use for the first time.

Volltext

Temporary structures are non-stationary structures that can be repeatedly erected and dismantled at different locations.

Temporary structures require a building permit before they are erected and put into use for the first time. Exceptions to this are the cases specified in Section 76 (2) sentence 2 of the State Building Regulations for Schleswig-Holstein (LBO). Construction permits issued by other federal states are also valid in Schleswig-Holstein.

The building supervisory authority under the Lord Mayor of the City of Kiel is represented by the Inspection Office for Structural Safety under the Lord Mayor of the City of Kiel when issuing, extending, amending and transferring construction permits for temporary structures.
