Teaser	In exceptional cases, you may be exempted from the obligation to wear a seatbelt or helmet at your own risk.
Volltext	<p>In order to protect road users, the legislator has stipulated that seat belts must be worn while driving and that safety helmets must be worn when driving motorcycles.</p> <p>However, it is possible to be exempted from this obligation on request. The resulting considerable safety risk is borne by the applicant.</p> <p>You can be exempted from the obligation to wear a seat belt</p> <ul style="list-style-type: none"> • if it is not possible to wear a seat belt for health reasons or • if your height is less than 150 cm. <p>You can be exempted from the obligation to wear a helmet if it is not possible to wear a safety helmet for health reasons.</p> <p>The exemption is revocable and usually granted for a limited period of time, unless it is a certified/documentated permanent condition.</p>

Erforderliche Unterlagen	<p>If the requirements for an exemption are of a medical nature, a medical certificate must be submitted stating that the exemption to be applied for is absolutely necessary for medical reasons. The certificate does not need to contain a diagnosis.</p> <p>A medical certificate or an official document must also be submitted as proof of height under 150 cm.</p>

Kosten	<p>The decision can be made free of charge for physically disabled persons.</p> <p>Otherwise, a fee of at least EUR 10.20 is charged in accordance with the scale of fees for road traffic measures.</p>
