These vehicles must primarily serve to maintain the vehicle's cultural heritage. Historic vehicles have an "H" in the last position of the registration number. Prerequisites: • The vehicle was first registered at least 30 years ago, • there is an assessment by an officially recognized expert from a technical inspection body or a test engineer from an officially recognized inspection organization and • the vehicle is largely in its original condition and in good condition. |

| | The application must be submitted in person or by a representative authorized in writing. The power of attorney must also include a direct debit authorization for the vehicle tax as well as your consent to the disclosure of the vehicle tax-relevant data to the authorized representative. If an application form is required, you can obtain this in advance from the relevant licensing authority or, |

For companies: natural persons: Business registration or extract from the commercial register, Partnership under civil law (GbR): Partnership agreement and power of attorney of the authorized signatories according to the contract. Electronic insurance confirmation, Direct debit authorization for vehicle tax (can also be filled out directly at the registration authority), If applicable, confirmation of reservation for the desired license plate. If the vehicle is registered additionally: Registration certificate part I (vehicle registration document), Registration certificate part II (vehicle registration of a vehicle as a classic car) and main inspection. If the vehicle was decommissioned before October 1, 2005, additionally: Certificate of decommissioning, vehicle registration document, Certificate according to § 23 StVZO (certificate for the classification of a vehicle as a classic car) and general inspection. If no operating license is available additionally: Registration document, Expert opinion according to § 23 StVZO (expert opinion for the classification of a vehicle as a classic car) and general inspection. |
