Volltext	<p>For the use of public waste disposal facilities, the public waste management authorities (districts, independent cities or special-purpose associations) charge fees or private user charges to cover the associated costs. In some cases, the fees are collected by the contracted waste management companies.</p> <p>The expenses to be covered by the waste fee include in particular the costs for</p> <ul style="list-style-type: none"> • Collecting, transporting and disposing of waste from households as well as disposal waste from commercial enterprises, other commercial enterprises or public institutions, • the marketing of recyclable materials, • waste consulting, • planning, construction, operation, aftercare, recultivation and renaturation of waste recycling and disposal facilities and • the formation of reserves for the foreseeable future costs of decommissioning and aftercare at waste recycling and disposal facilities. <p>The scale of charges is intended to create effective incentives for prevention and recycling.</p>
