If you have not received a notification by mistake, please contact your local authority (town hall, district administration). The electoral roll is available for inspection at your local authority from the 20th to the 16th day before the election. If you are entered in the electoral roll, you can also vote or apply for a postal vote without a polling card. You can apply for a postal vote in writing (e.g. using the polling card application form on the back of the election notification), by email or in person at the polling station. Many municipal authorities also have |
