Teaser	Employers are responsible for ensuring that their employees do not suffer any accidents at work and that their health is not endangered.
Volltext	<p>Employers are responsible for ensuring that their employees do not suffer any accidents at work and that the working conditions do not endanger their health. They must therefore comply with a number of legal regulations. In particular, they must determine which specific hazards may exist at the individual workplaces (risk assessment). Such hazards may, for example, lie in the type of tool, e.g. cutting injuries from a knife. However, they can also be caused by the handling of certain hazardous substances such as solvents or by the design of the workplace, for example if the lighting is poor or there is a risk of tripping.</p> <p>In his risk assessment, the employer must also take into account that certain groups of people, such as young people or pregnant women, may be particularly at risk and may therefore not be allowed to carry out certain tasks.</p> <p>In any case, the length and location of working hours and breaks must be included in the assessment: Excessively long working hours, lack of breaks or shift work can lead to increased accident risks or health problems. This applies in companies and on construction sites as well as for the workplaces of drivers in freight or passenger transport.</p>
