Teaser	Anyone wishing to take the journeyman's examination at the end of their training in the skilled trades requires a license to do so.
Volltext	<p>At the end of a recognized vocational training course in the skilled trades, you as a trainee (apprentice) must demonstrate your professional skills in the journeyman's examination.</p> <p>In order to be admitted to the journeyman's examination, you must</p> <ul style="list-style-type: none"> • have completed the training period prescribed in the training regulations, • have passed the prescribed intermediate examination/part 1 of the journeyman's examination and provided proof of training, • register for the examination or have your trainer register you for the examination. <p>In addition, your vocational training relationship must be entered in the apprenticeship register. This does not apply if the entry is missing for a reason for which neither the apprentice nor his/her legal representative is responsible.</p> <p>Persons who have been trained at a vocational training institution are also admitted if this training course corresponds to vocational training in a recognized training occupation. In the case of appropriate performance, trainees may also be admitted to the final examination before the end of their training period following a hearing. External candidates and/or candidates without previous vocational training but with sufficient periods of professional activity are</p>

	<p>admitted according to special regulations.</p> <p>If the journeyman's examination is carried out in two parts at different times, admission is decided separately in each case.</p> <p>The chairperson of the examination board decides on admission to the journeyman's examination. If he/she does not consider the admission requirements to be met, the examination board will decide.</p> <p>A written certificate is issued to the candidate as a result of the examinations.</p>
Erforderliche Unterlagen	<p>For the first examination:</p> <ul style="list-style-type: none"> • Registration form, • Copy of the certificate of participation in the intermediate examination/part 1 of the journeyman's examination, • prescribed training record booklets, • Copy of the certificate of participation in prescribed instruction measures. <p>In the case of the repeat examination, also: Copy of the vocational training contract or copy of the application for extension of the vocational training contract.</p>

Hinweise	<p>Trainees must be released from work to take examinations. Trainees will continue to receive their training allowance for the time they are released from work.</p>

	<p>People with disabilities should indicate their special needs when registering for the journeyman's examination so that these can be taken into account when the journeyman's examination is held.</p> <p>Trainees who have taken parental leave must not be disadvantaged by this when deciding on admission.
