Teaser	Would you like to work in Germany for a limited period as a veterinarian with a professional qualification from the European Union, Switzerland and the European Economic Area? Then you need a permit for this
Volltext	<p>The profession of veterinarian is regulated in Germany.</p> <p>This means that you can work as a veterinarian in Germany without restriction if you have a license to practice.</p> <p>If you have completed training as a veterinarian in the European Union (EU), the European Economic Area (EEA) or Switzerland, but do not have a license to practice medicine and only wish to practice the veterinary profession for a limited period of time, you only need a permit.</p> <p>The permit entitles you to use the professional title "veterinarian".</p> <p>The permit can be restricted to certain activities and employment positions.</p> <p>It may only be issued or extended on a revocable basis and only up to a maximum total duration of 4 years of veterinary activity.</p>

- Proof of identity (identity card or passport)
- If applicable, birth certificate or marriage certificate if the name in the documents differs from the current name
- Professional qualification (veterinary diploma, examination certificate or other proof of veterinary qualification/training)
- Proof of the content and duration of your training (e.g. diploma supplement, transcript of records)
- Handwritten and signed curriculum vitae in tabular form with a focus on previous professional training and activities
- Employment contract
- Proof of your personal suitability: Criminal record extract from the country of origin or official certificate of good conduct for submission to an authority. This certificate must not be older than 1 month at the time of application.
- Proof of your health suitability: Medical certificate. This certificate must not be older than 1 month at the time of application.
- If applicable, proof of the language skills required to practise the veterinary profession

Note: You must enclose a German translation of documents in a foreign language. The translation must be carried out by an officially sworn translator.

Voraussetzungen

- You must have completed training for the veterinary profession.
- You would like to work as a veterinarian in Germany for a limited period of time.
- You are reliable to work as a veterinarian and have no criminal record relevant to your profession.
- You are medically fit to work as a veterinarian.
- You have the German language skills required for the job.
- You have an employment contract for work as a veterinarian

Verfahrensablauf	<ul style="list-style-type: none"> You submit a written application to the competent authority of the federal state in which the veterinary profession is to be practiced. The competent authority will decide on the license after examining your documents.
Bearbeitungsdauer	<p>4 - 6 Woche(n)</p> <p>The processing period with final issuance of the temporary professional license is approximately 4-6 weeks from the date on which the application documents are complete.</p>
Frist	<p>4 Jahr(e)</p> <p>The application for a temporary professional license must be submitted before practicing the veterinary profession and is valid for a maximum of 4 years. The application must be submitted before you start working as a veterinarian.</p>

Hinweise	Acting as a veterinarian before obtaining a temporary license to practice as a veterinarian can lead to criminal prosecution.

Kurztext	<ul style="list-style-type: none"> Permit for the temporary practice of veterinary medicine Issued to veterinarians from EU member states <ul style="list-style-type: none"> In Germany, a state license (Approbation) is required for temporary work as a veterinarian. In individual cases, a temporary professional permit may be issued instead of a license to practice. This permit must be applied for from the competent authority in the country in which you wish to work as a veterinarian. Proof must be provided that you have completed training for the veterinary profession.
