Volltext	If you move to an inland vessel that is registered for a domestic ship register, you must register. If you are sailing on a seagoing vessel that is entitled to fly the federal flag, the shipowner must register you. For this purpose, you must provide the shipowner with the necessary information. The obligation to register does not apply in either case if you are registered for a dwelling in Germany.

Kurztext	If you move to an inland vessel that is registered for a domestic ship register, you must register. The obligation to register does not apply in either case, insofar as you are registered for a dwelling in Germany.
