Teaser	Companies that install or maintain refrigeration and air conditioning systems or heat pumps that contain fluorinated greenhouse gases require certification.
Volltext	The Chemicals Climate Protection Ordinance applies in addition to the European Regulation on Fluorinated Greenhouse Gases. It stipulates that, in connection with the European implementing regulation, companies that carry out maintenance, servicing and installation work on stationary refrigeration and air conditioning systems and heat pumps that contain fluorinated greenhouse gases must, must be certified.
